SALIC LAW contested the pace along the inside, drew clear when roused, drifted out in deep stretch and was driving under the wire. NIADHAS raced in hand early, rallied inside on the turn, angled out in the stretch, was carried out in deep stretch and finished gamely. LENNOXWOOD raced close up while three wide and lacked a rally. GOAL POST contested the pace from the outside and tired in the final furlong. MACAO had no response when roused. DEVIL'S COMMAND was rated along early and tired. PAYOFF tired. Following a Stewards' inquiry into the stretch run Salic Law was disqualified from first position and placed second for causing interference in deep stretch.
