MARKOFEXCESS, never far back while following the leaders four wide, wrested command in the upper stretch and widened under intermittent urging. PLEASANT PATTERN pressed front-running LINDSTROM four wide from early on, stuck a head in front briefly on the turn, lost the edge back to LINDSTROM in the upper stretch, lugged in bothering LINDSTROM at the sixteenth pole, then wasn't a match for the winner late. FORZAS PRIDE, bumped at the start by HOOFIN' IT and never far back, raced three or four wide and couldn't muster a closing bid. LINDSTROM rushed to the front inside early, was headed from the outside on the turn briefly by PLEASANT PATTERN, regained a slight edge in the upper stretch, weakened, then was steadied sharply at the sixteenth pole when PLEASANT PATTERN lugged in. ROME IS BURNING raced in contention five wide into the lane and was empty when the test came. HOOFIN' IT drifted in at the start bumping FORZAS PRIDE and wasn't a serious factor. NOIFSNOADSNOBUTS followed the pace in a striking position four or five wide to the lane and weakened. ORO BRAVO, sluggish to start and squeezed back, never was close. FOLLOWING A FOUL CLAIM BY THE RIDER OF LINDSTROM AGAINST PLEASANT PATTERN FOR ALLEGED INTERFERENCE IN THE STRETCH, STEWARDS DISQUALIFIED PLEASANT PATTERN AND PLACED HIM FOURTH.
