TOMMYLEECAT made a middle move, fanned six wide into the stretch then loomed a threat in the furlong grounds before hanging late. AFORTUNADO made an inside middle move, angled off the rail to attempt to rally from between rivals then was pushed out into WAR HAWK in mid stretch when TALBOT COUNTY came out then also hung late. TALBOT COUNTY broke a step slow, rushed to the lead from between rivals, held a clear lead to the furlong grounds then came out in mid stretch before being straightened. WAR HAWK made a four wide middle move to bid out of the turn to mid stretch then was bumped by AFORTUNADO and weakened. FIRST CLASS TRIP was through after a half. SIR ROYALE was also after a half. MAJOR PRICE flashed brief speed.
